Observed collection

In an observed setting, donors collect their own oral fluid sample, and they do not need access to a private restroom facility—helping to reduce the risk of donor cheating.

How it works:

from collection to results in minutes



1. Collection

The donor inserts the collection swab in their mouth and swabs until the swab is fully saturated. The saturation indicator strip will appear once the proper specimen amount is collected.



2. Test

Gently and slowly insert the collection swab into the test device, swab first, until it reaches the bottom of the test device. Push the cap until it locks in place and is secure.



3A. Employer-read results*

Within minutes of activating the test, negative results can be read using the test and control lines on the test strips.

3B. Quest-read results*

If we will be interpreting the results remotely, follow the process to authenticate user, complete collection, scan QR code, capture image of device strips, and report out the result.

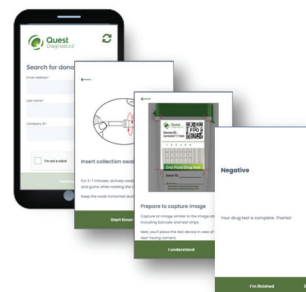
*If the results are non-negative, specimen can be sent to a Quest laboratory for confirmation.



4. Reporting

If interpreting results yourself, they can be stored in a variety of ways, either via a digital file (PDF) or manually entered into our Quest Diagnostics Employer Solutions Portal (ESP). If using remote interpretation, the results are automatically loaded into the ESP and can be transferred directly to your system.

Support of remote interpretation software add-on option ensures that any questionable results are **validated by Quest experts and transferred right into your ESP once results are ready.**
